Equal rights for all!

The UN Convention on the Rights of Persons with Disabilities Inclusion is a human right. Established in the UN Convention on the Rights of Persons with Disabilities of 2006. All people should participate with equal rights in community life. Nobody should be disadvantaged because of a disability. The Convention has been law in Germany since 2009.

Hessen must therefore take the measures necessary for its implementation. Inclusion has been legally enshrined in the Hessen Schools Act since 2011. The city of Frankfurt am Main has committed itself in its "Inclusion Guidelines" to the comprehensive implementation of inclusion.



Everyone should be a part of society! We are doing everything to make that happen.

There are still too many barriers to inclusion. The Independent Inclusion Advice Service Frankfurt helps to overcome them, and assert the right to equal opportunities in all areas of life:

We advise parents and their children with disabilities

independently and free of charge. By telephone, e-mail, and in personal meetings at locations of their choice. If necessary, we also have contacts with foreign language and sign language interpreters.

We provide clarification

about legal rights, obligations and individual options.

We find personal solutions

and support their implementation.

We find the right contact partners

for all questions to do with inclusion.

We connect parents

and provide assistance with self-help, e.g. through parents' meetings, information events, support of parents' initiatives.

We inform and train specialists

(e.g. child day-care centres, early support offices, children's/youth/disabled aid) on processes and implementation of inclusion.

Independent Inclusion Advice Service expertise includes, amongst others

- Transition from day-care centre to school
- Inclusive school education at primary and secondary schools
- Entitlement to special teaching support
- Participation assistance in accordance with SGB VIII § 35a and SGB XII § 54
- Support for parents facing legal action and appeals regarding school choice/participation assistance
- Transition from school to employment; inclusion via "personal budget"
- Inclusive living, leisure and employment options

Gemeinsam leben Frankfurt e.V. is an independent, non-profit association which aims to promote equal opportunities for disabled people in Frankfurt by means of pioneering projects.

The founders and board members are parents of people with disabilities and specialist educators with comprehensive experience concerning inclusion. We know from our own experience what inclusion needs in order to function. We devote all our efforts to this end on the basis of the UN Convention on the Rights of Persons with Disabilities. The work of the Association is carried out by voluntary board members and paid employees of the Association.
